

OVER 220 PEOPLE ATTENDED ONE OR MORE DAYS OF THE LAKE ROOSEVELT FORUM'S 2004 ANNUAL CONFERENCE. Entitled Collaborating for the Future, the conference featured diverse sessions and presentations regarding water quality, fisheries and

community development.



Participants came from throughout the Columbia Basin, including Canada. They represented federal, state and local agencies; tribal members and representatives; elected officials; watershed councils, conservation groups and other associations; property owners; local businesses; and interested citizens.

During the first two days of the conference, sessions and keynote addresses resulted in



over 60 presentations being made. On the final day, in depth work group meetings were held by the Upper Columbia White Sturgeon Recovery Team, Lake Roosevelt Noxious Weed Collaborative and an EPA Availability Session.

This year, the Forum is pleased to share the proceedings of the conference on the enclosed CD.

Public Hearings to be Held on State's Columbia River Initiative

ONE OF GOVERNOR GARY LOCKE'S FINAL PROPOSALS may also be one of his most ambitious. As reported in the Forum's last newsletter, the Columbia River Initiative includes the possibility of drawing Lake Roosevelt down further during certain parts of the year.

To move this initiative forward, the Washington Department of Ecology has prepared a draft rule. Public hearings (see side bar) are now scheduled to explain this Initiative, answer questions and receive comments.

As described on Ecology's web page, the initiative "is designed to institute a new water resources management program for the Columbia River mainstem. The proposal establishes a framework for issuing new water rights from the Columbia River, while simultaneously improving stream flows for fish populations. Gov. Locke's plan includes:

- An executive-request bill for lawmakers to consider during the 2005 legislative session.
- Capital and operating budget requests of \$79 million over the next 10 years to secure water and to conduct feasibility evaluation of new off-channel storage projects.
- Cooperative agreements with federal and local partners to obtain water.
- Draft rule language to implement the program. The Department of Ecology (Ecology) will not adopt the proposed rule prior to receiving direction from the next governor and the legislature.

The Forum strongly encourages people to participate in one or more of these hearings.
